76th Annual NLG National Convention

The 76th Annual NLG National Convention will be held in San Juan, Puerto Rico from October 23 to 27, 2013. There is still time to register for this historic convention. This year, Puerto Rico marks the 115th anniversary of the U.S. invasion. Since 1898, Puerto Ricans have struggled to end U.S. colonial control. Thousands have gone to prison in the name of independence. The NLG has a long history of supporting Puerto Rican independence activists and this fall, NLG members are invited to celebrate that history and build solidarity at the 76th Annual Law for the People convention in San Juan, the first ever Puerto Rico Guild convention. This will be a historic convention and an important affirmation of the NLG's solidarity with people seeking self-determination in Puerto Rico and around the world. All Chicago Guild members are encouraged to attend this Convention.

At the convention the 2013 Law for the People Award will go to Judith Berkan and Chicago's own Jan Susler, both long time NLG members united in their work with the Puerto Rican independista movement. Jan Susler's work on behalf of political prisoners' and prisoners' rights spans decades; since 1982 she has worked with the People's Law Office in Chicago. For over three decades she has represented Puerto Rican political prisoners, and she served as lead counsel in the efforts culminating in the 1999 presidential commutation of their sentences. Congratulations to Jan for this well deserved honor!

In addition to workshops and meetings the Convention will sponsor excursions and walking tours to explore Puerto Rican history and culture. And then there is always the warm sun of the Caribbean!

The Mass Defense Committee (MDC) was formed in February 2011 in response to requests from community allies for legal assistance related to political demonstrations. The committee oversees the Legal Observer Program and providing representation for individuals who are arrested at demonstrations. Recently, MDC members have represented movement allies in administrative hearings and criminal cases resulting from protests against the CPS plan to close 50 public schools. We have also fielded Legal Observers for many demonstrations related to the school closures and other CPS activity that adversely impacts community members. National Police Accountability Project (NPAP)

A handful of NLG members, including several folks from Chicago, formed a national project around issues of police brutality and law enforcement misconduct approximately two decades ago. The National Police Accountability Project (NPAP, www.nlg-npap.org) has grown to include more than 500 members across the country. NPAP is dedicated to ending police abuse of authority through coordinated legal action, public education, and support for grassroots and victims' organizations combating police misconduct. Members participate in a national listserv, CLE programs, and a Section 1983 Subscription Series. NPAP is a non-profit organization of plaintiff's lawyers, law students and legal workers, headquartered in New York City.

In 2008, a local group began meeting and sharing ideas, litigation strategies and sharing experiences in litigating police misconduct cases. The Chicago NPAP is made up of NLG members and nonmembers as well as national NPAP members and nonmembers. Everyone is encouraged to be a member of NLG and NPAP. Attorney Ken Flaxman maintains a list serve for us of more than 75 individuals and regularly provides district court and Seventh Circuit decisions in the area of civil rights litigation. (dis)Orientation

On Saturday, September 21, over 40 students from all 6 Chicago law schools gathered for the fourth annual city-wide (dis)Orientation. Students from Madison and Northeastern, and Guild lawyers, also attended.

At (dis)Orientation, students learned about the Guild's progressive roots with many examples of the Guild being on the right side of history. In her "Welcome to the Guild!" speech, Molly Armour explored much of the Guild's strong history, the structure of the Guild, and a clear vision forward both nationally and locally.

Students also heard some tips and tricks for surviving law school (and keeping their soul!) from fellow student leaders, including Chicago student representative and Loyola 3L Emily Coffey, Chicago-Kent president and 3L Charlie Burns, Northwestern president and 2L Vikki Otero, and John Marshall president and 2L John ("Jack") McCoy. Students then enjoyed lunch and the ability to meet and mingle with likeminded students.

After lunch, students heard what they won't hear in the classroom: an introduction to critical theory. Chicago Kent's feminist theorist Nancy Marder spoke about the many feminisms and the law, and Alvar Ayala of Workers Law Office P.C. spoke about race and the law and specifically how it impacts low wage workers.

Students then selected to attend either a Legal Observer training or a First Defense Legal Aid training. Skye Allen and Sharlyn Grace trained a group of new legal observers, who are now ready to protect against unconstitutional abuses of police power. Upperclass students were trained by FDLA to protect the rights of those in police custody in the hours before they are charged and a public defender can be appointed.

The final panel explored the many possible career paths a People's Lawyer might take. Michelle Vodenik, Chicago-Kent's Diversity Coordinator and Public Interest career advisor, moderated the discussion and offered advice on pursuing the a career working for the people. Lili Jimenez, Chicago Guild board member and TUPOCC co-chair, explained her career at the Department of Labor guarding against wage theft and pioneering the way for undocumented immigrants who are victims of workplace abuse to receive u-visas. Ryann Moran of Cabrini Green Legal Aid explained her work fighting for the right to housing, especially for those who are at risk of losing their housing as a result of an interaction with the criminal legal system. Jan Susler, partner at People's Law Office, explored her work representing the rights of prisoners and representing members of the Puerto Rican Independence Movement.

Students were then welcomed to the Guild with open arms at NextGen's happy hour at Dylan's. (dis)Orientation 2013 was a success and students left feeling reinvigorated about their decision to attend law school and hopeful about the good work they are on their way to doing.
